The board by circulation recommended the auditor's office Saleh, Barsoum & Abdel Aziz (Grant Thornton) to perform audit work of the company for the financial period from 1 July 2025 to 31 December 2025, for a total contractual value of EGP 1,000,000 (only one million Egyptian pounds), excluding value-added tax (VAT), as per the following breakdown:

By the following terms and conditions:

- 30% of the total fees shall be paid as an advance payment, with the remaining balance payable upon completion of the service.
- The fee for issuing professional certificates is EGP 50,000 (only fifty thousand Egyptian pounds) per certificate.
- The above-mentioned fees are exclusive of accommodation and transportation expenses, which are estimated at EGP 300,000 (only three hundred thousand Egyptian pounds).
